The transition to university-based education for paramedics has led to the development of a more professional role, and to a desire to adopt a more traditional approach to professional career pathway development. Undergraduate education provides a professional baseline, but future career development depends on the acquisition and maintenance of enhanced competencies.

#### GRADUATE YEAR OF PRACTICE



The **Graduate Year of Practice** further develops the clinical, personal and professional skills that form the basis of future practice.

The program integrates the relevant skills, knowledge and attitudes to provide graduates with a thorough grounding in professional paramedic practice and is designed to recognise, support and enhance workplace learning.



#### PROGRAM DESIGN

The **Graduate Year of Practice** supports graduate paramedics and those close to graduation to successfully transition to the workforce.



The program's curated curriculum is designed to provide comprehensive learning relevant to graduate paramedics.

Content is based on the professional capabilities required for the safe and effective practice of paramedicine and focuses on the whole practitioner. Each level builds on pre-existing knowledge and skills to enhance the expertise of the graduate paramedic.

An elective module within the Graduate Year of Practice, this low-commitment, highly interactive and supportive program runs for four weeks.

## Self-paced module (Online)

#### Paramedic 102: Enhancing work readiness with human factors

Explore various human factors that influence work readiness.

- **Part 1:** introduces the concept of 'work readiness' with two self-assessment activities to complete.
- Part 2: looks at personal human factors, such as personal values and self-awareness.
- Part 3: considers professional human factors, including professional conduct and accountability.

With a deepened understanding of these factors, you will be better prepared to embark on your professional career as a paramedic.

#### Self-paced module (Online)

### Paramedic 103: Supporting personal wellbeing in the workplace

Paramedic work is demanding but, with the right tools and approach, you can enjoy a long and rewarding career. This module looks at stress, pressure, and burnout: What are they? How can we recognise them? And, most importantly, how can we manage them? We also tackle imposter syndrome – a common challenge for new graduates. Finally, we guide you through a 5-day mental health challenge and introduce you to key techniques for maintaining your mental wellbeing.

- Apply ethical frameworks to real-life scenarios, demonstrating ability to navigate ethical challenges
- Discuss the effects of bias and racism in paramedicine
- Apply knowledge and skills into real-world scenarios
- Analyse complex clinical scenarios through interactive, case-based learning and demonstrate effective decision-making skills in high-stress environments to enhance critical thinking
- Evaluate case studies online and adapt your approach to patient care based on findings

Engage in discussions that delve into the importance of personcentred care, exploring how ethical practice and professional standards can be integrated into your daily work. Develop an understanding of essential ethical frameworks and key principles such as duty of care, informed consent, and mandatory reporting. Learn to navigate the ethical challenges that can arise in various work environments, enhancing your decision-making skills.

#### Career development in clinical practice

Discover strategies to excel during your graduate year, identify potential pitfalls to avoid, and receive invaluable advice on laying a strong foundation for your clinical career.

#### Turn biases into insight

Through engaging case studies and reflective conversations, broaden your understanding of cultural diversity in patient care and learn how to adapt your approach to effectively meet the needs of diverse communities.

#### Clinical skills and critical thinking

- recognising critical warning signs and determining when advanced intervention is warranted. Hands-on practice will enhance your confidence in responding to emergencies and provide insights into managing complex presentations.
- insights into the multifaceted nature of pain. Learn how to conduct thorough pain assessments, recognise signs and symptoms in patients, and tailor pain management strategies to individual needs. Discuss common misconceptions and biases regarding pain perception.

Understanding that mental resilience is just as vital as physical strength, the discussion revolves around strategies to support both aspects. Techniques such as stress management, regular physical training, and mindfulness practices are essential for maintaining overall well-being and performance, allowing paramedics to cope with the demands of their jobs effectively.

#### Culturally responsive care

Develop greater insights into the importance of culturally responsive care. Equip yourself with the skills to understand and respect patients' diverse cultural backgrounds to enhance care quality and build trust in the paramedic-patient relationship. This approach not only enhances communication but also builds trust and improves patient satisfaction and outcomes, particularly in diverse communities.

### Working in an emergency care environment: enhancing safety through proactive strategies and awareness

This area examines the complexities of functioning in emergency care settings, focuses on implementing proactive safety measures and the importance of situational awareness in the field. It underscores the need for strong communication skills and teamwork within multidisciplinary units, as effective collaboration is pivotal for successful patient outcomes. The ability to adapt quickly, prioritise care, and remain calm under pressure are highlighted as critical skills for paramedics operating in high-stakes environments.

This topic advocates for a comprehensive approach to patient care that addresses the physical, emotional, and social needs of individuals across all stages of life. It emphasises the importance of recognising the unique healthcare requirements of children, adults, and the elderly. Investigate how interventions should be tailored to support the diverse needs of patients holistically, ensuring that every aspect of a patient's well-being is considered during assessment and treatment.
